D. Arkansas Head Start Association Strategic Planning Update:

New Business:

A. Racial Equity Webinars and Website: Jackie Govan shared that it will be launched by the end of July. We will have 3 webinars planned for August, October, and November.

Reports:

A. Arkansas Early Childhood Commission (SAC)-Barbie Baxter shared that it was a very productive meeting-the first in person meeting since COVID.

B. Arkansas Head Start-State Collaboration Office-Jackie Govan shared that she is continuously meeting with the PDG group which is working on infant/toddler expansion as well as trauma informed care. She has been collaborating with Arkansas Community Action Agencies Association as well as CSBG. They have developed an MOU outlining the partnership. She has helped setup a joint meeting between Head Start Disability Specialists and the ECSE Coordinators but we need more Head Start representatives to attend. Jackie is still working on homelessness in Arkansas. She is putting together a diverse committee to look at ending homelessness. Jackie has received questions about lead in the water and referred programs to the Information memorandum released by OHS that shares precautions that programs need to take. James Hollywood was the presenter of the last Powerful Interactions with Fathers. Senator Clarke Tucker will be the speaker in August. She asked programs to please share information about the statewide activities. The next Dads Reading on the Carpet will be held in North Little Rock on July 14.

C. Region VI Head Start Association-Jackie Burton shared that the Region VI Board will meet on May 22, 2023. The conference will be July 17-21, 2023 in New Orleans.

D. Arkansas Head Start Association Institute-Jackie Burton shared that the committee approved the cover page and selected the dates of February 29-March 1, 2024 as the next dates for the institute. She encouraged programs to register for the institute.

E. National Head Start Association Updates-Jackie Govan shared that the new OHS Director Khari Garvin presented at the NHSA Conference. Jackie serves on the Research and Evaluation Committee as well as the Membership Committee. NHSA has elected new Board Officers.
